

# NOMINATION OF EXAMINERS AND THESIS SUBMISSION FORM MCGILL

*Doctoral Thesis Nomination of Examiners Form. Submit this completed form to carriagehouseautoresto.com@carriagehouseautoresto.com from your official McGill email address.*

If necessary, please use underscores instead, e. The student is not to see the reports until after the oral defence. The student should not contact potential examiners. The student will be given copies of all reports at the conclusion of the defence. If you do have spaces in your final e-thesis file name, you will not be able to delete the final e-thesis from the file server should you need to do so. The examiner should not have been involved in supervising the thesis. This is done by submitting a Nomination of Examiners and Thesis Submission form, which must be approved by the Department. Once approval is obtained, the form is signed by the Department Chair and returned to the supervisor. In case you decide that the file you uploaded must be replaced with another, you will have to delete the file already on the server. If the thesis has not been passed, see Thesis Examination Failures. Do not use spaces in the file name. If you are ready to submit your final corrected copies and are blocked from the e-Thesis form, please thesis. The Thesis Office arranges for the review of the thesis by the external examiner. Your final e-thesis must be a single. Objectivity of the Examination Process Once the thesis has been submitted, no one outside of GPS should attempt to communicate with the examiners regarding the thesis, nor should the examiners communicate with one another or with the student or the supervisors until the examination process is complete. The label should list a the thesis title, b your name, c the department name, and d the program i. Your name and program should be clearly marked on the spine of the thesis and a typed label prepared for the front cover. Plagiarism In cases where plagiarism is suspected, the examiner must return the thesis and report the suspected plagiarism, citing sources of the original material that was allegedly plagiarized. You can view your final e-thesis on eScholarship McGill. In cases where plagiarism in the thesis is charged, the thesis examination does not proceed and the case is investigated through a University disciplinary process. You can only have one 1 file uploaded at any one time. An external examiner from outside McGill must also be selected. Only thesis students who have a status of "pass awaiting finals" internal Banner code meaning: ready to submit the final corrected copies of a thesis can upload a final electronic thesis to Minerva. All questions regarding the examination or defence should be addressed to the thesis. This form is then submitted along with the thesis. The instructions to re-direct your e-mail are on the Network and Communication Services website. Related Content. The GAC typically meets on a monthly basis. Facebook Prior to submitting a thesis for external review, the thesis examiners must be selected. If you have a co-supervisor, you will need four copies. Students are strongly encouraged to upload their final e-theses for online supervisor approval well in advance of the Deadline for Submission of Final Copies , otherwise the final e-thesis may be approved too late for the intended date of graduation. Five copies, or six if there is a co-supervisor, should be submitted to the Department GPC along with a copy of the completed Nomination of Examiners and Thesis Submission Form. The Department is responsible for sending a copy of the thesis to the internal examiner and the supervisor. If you are not using your official McGill e-mail address, please ensure that you redirect e-mail from that address to your preferred e-mail address. Final Deposition Once all corrections have been made, the final thesis is submitted through e-Thesis. Previously submitted theses can be found on the McGill Library website.
